Who is eligible to enroll for the YKHC Employee discount for YKFC memberships?

Full time regular employees of YKHC are eligible to enroll for the subsidized membership.

Temporary employees are not eligible for subsidized memberships, but may bring their badge to the YK Fitness Center desk for a discount.

How do I enroll? Enrollment forms are available from the YK Fitness Center front desk, YKHC Human Resources, or email <u>ykfc@cityofbethel.net</u>.

When can I enroll in a membership? Today! Enrollment is accepted on a rolling basis.

Why are the rates for employees and family members different? In addition to the YKFC discount, YKHC provides a generous subsidy for the employee to help cover the membership cost for employees. Family members only receive the YKFC discount.

Frequently Asked Questions about YK Fitness Center memberships for YKHC Employees.

How do I pay for membership?

<u>Annual memberships</u> are paid directly to the fitness center, in full for the year. We accept cash, credit/debit. Annual memberships start immediately.

<u>Monthly memberships</u> are paid through payroll deduction. Deductions take 4-6 weeks to setup and are subtracted from the 2nd paycheck of each month. Applications must be received by the 5th of the month to make the payroll deduction deadline. Monthly applications received after the 5th of the month will be processed for the following month's enrollment.

When will my membership begin?

- Annual memberships begin immediately.
- Monthly memberships begin after your first payroll deduction is received. Deductions are taken from the second paycheck of the month. Your membership will begin the first of the following month. Applications must be received by the 5th of the month to make the payroll deduction deadline. Monthly applications received after the 5th of the month will be processed for the following month's enrollment.
 - Example: application received May 5th = payroll deduction will be the 2nd check of May and membership will start June 1st; application received May 6th = payroll deduction will start 2nd check of June and membership will start July 1st.
